1st Ed Credit Union experienced a lot of change in 2017 while maintaining the continued goal of serving our members.

Being an education-based credit union, providing financial education to our members and our community continues to be one of our top priorities. As part of our desire to do this, one of our most exciting changes in 2017 was opening a new student branch at the Franklin County Career and Technology Center. The student branch provides a convenient service location for the staff and students, but most importantly it provides an outlet for financial education for the students.



We continued our goal to educate the youth of our schools in 2017 through classroom presentations at elementary schools about the importance of saving money as well as provided an online, interactive learning program for the 8th grade class of Chambersburg Area Middle School North that teaches the students about budgets and making sound spending decisions. We also held financial education reality fairs at numerous high schools where students get a taste of reality when they chose their career path and planned their monthly budgets which provided real life scenarios on what to expect upon graduation. In 2017 we proudly awarded four \$1500 college scholarships to area high school seniors and assisted members with achieving their academic goals by providing flexible, low-interest student loans.

Our members are at the root of who we are and why we exist. 1st Ed continues to uphold the credit union philosophy of "people helping people" and in 2017 we participated in many community outreach events. The credit union, its staff, and the members were able to give back to the community through donations to the Cumberland Valley Animal Shelter, The Boys and Girls Club, South Central Community Action Program, PA Credit Union Foundations, and by sponsoring the Chambersburg Area School District's Indoor Track and Student Section at the Chambersburg Area High School.

As an extension to our computer system upgrade at the end of 2016, our debit and credit card system was also upgraded in 2017, this upgrade provided the opportunity for expansion and growth to better serve you, our members. Through these upgrades we have been able to continue to provide convenient electronic services along with enhanced security by giving our card holders more control when utilizing their debit and/or credit cards. 1st Ed continues to be a viable lending resource for our members and in 2017 we loaned out \$14.5 million in loans.

We continue to appreciate our loyal members and strive to provide the best products and services we can to better serve you while assisting in helping you achieve your financial goals.

REPORT OF THE SUPERVISORY COMMITTEE

The Supervisory Committee serves as the audit committee for the credit union. This committee is comprised of three members, and their role is to ensure the accuracy of financial records and to review new policies and procedures of the credit union.

The Supervisory Committee engaged the independent accounting firm of Smith Elliott Kearns & Company to perform monitoring procedures to ensure the committee can meet its responsibilities to the credit union and members. Procedures included an arbitrary review of new loans and new investment policies, as well as monitoring the compliance of other Bank Secrecy Act and Anti-Money Laundering policies. Procedures included random cash counts, verification of proper loan interest, and dividend calculations. The committee is pleased to say there were few exceptions found and the credit union received satisfactory reports.

The Supervisory Committee also engaged the independent accounting firm of Smith Elliott Kearns & Company to audit the credit union's financial statements as of March 31, 2017. The committee is pleased to report that the annual audit was successfully completed, and the credit union's financial statements were certified without qualification.
